Lunsford's Musical Instruments may take possession of the listed instrument wherever the same may be found (including from school), without notice to the renter, without liability to the rentee, and without prejudice to any legal remedies of Lunsford's Musical Instruments. In the event of default on any of the terms of the agreement, renter shall pay all collection fees, any and all legal expenses, including attorney fees and re-trial cost at the maximum chargeable interest on the amount of any judgment awarded. Any action at law, suit in equity, or judicial proceeding for the enforcement of this contract or any provision thereof shall be instituted only in the courts of the state of Tennessee, county of Knox.
